David welcomed attendees and opened the meeting by tabling the financial statement obtained by Horace observing that we are tracking reasonably well within budget on a month to month basis noting the following concerns:

- a) An entry of \$940.00 for Signs/Linemarking. There was no recollection of what this expense related to but is possily for basement floor signage; Horace currently investigating.
- b) Electrical maintenance costs were high and well over pro rata, and it is assumed that this was associated with the high cost of replacement of inverters (not a recurring cost) and downlights. It was hoped this rate of expenditure will slow down in the mpnths ahead. Shelley took the opportunity to provide an update on her discussions with her brother regarding lead times associated with delivery of "Cats Eyes" lamps. In summary, the maximum lead time for delivery would be one month and should have a three year warranty period. Shelley undertook to provide Horace with her brother's contact details to investigate further. David updated the meeting with the present state of play with unserviceable cats eyes. The contractor is reportedly awaiting replacement transformers.
